SKA Offices 1.1 2011 - Criteria:

All partitions meet at least one of the following criteria:

- are reused;
- if new, are manufactured with at least 10% recycled content;
- have an A or A+ rating in BRE's The Green Guide to Specification;
- have an A or A+ rating in BRE's Green Book Live database; or
- are supplied with an environmental product declaration, written in accordance with ISO 14025 standards.

if timber or containing timber elements, the timber meets the criteria of good practice measure D20 Timber.

SKA Offices 1.2 2013 - Criteria:

All partitions meet at least one of the following criteria:

- are reused;
- are re-locatable (see below for guidance),
- are manufactured in a factory that has achieved and maintains an Environment management system in accordance with BS EN ISO 14001

if new, are manufactured with at least 90% recycled content and 100% recyclable content, designed for deconstruction with components that can be recycled measured by mass.

- are supplied with an environmental product declaration, (other than that written for the Green Book Live), written in accordance with ISO 14025 standards; or
- if timber or containing timber elements, the timber meets the criteria of good practice measure D20 Timber.

SKA Retail 1.0 2012 - Criteria:

All partitions meet at least one of the following criteria:

- if new, the panels are manufactured with at least 90% recycled content;
- have an A or A+ rating in BRE's The Green Guide to Specification for the retail scheme;
- Have an A or A+ rating in BRE's Green Book Live Database for the retail scheme;
- are supplied with an environmental product declaration (other than that written for the Green Book Live), written in accordance with ISO 14025 standards; or
- are re-locatable (see guidance for definition).

A re-locatable or reusable system can be removed and Relocated without substantial Repair; it should be capable of Reinstallation within a tolerance of $\pm 10\text{mm}$ of the original Installed height.

Viso Fire & Acoustic Solid elements

Is a 75mm and 100mm + drywall system. Steel framework is constructed using cold rolled steel Studs with a one part aluminium head track and two part Trim sections finished with Plasterboard with various joint Finishes.

Viso Single Glazed – Fully Glazed Partitioning

Our fully glazed partitioning is available in single glazed, Using 25mm wide Head, wall and floor sections
It utilises a low carbon clear glass dry joint in lieu of silicone
Silicone can still be used as an alternative Joint detail

Viso Single Glazed can also be specified and installed using a two part relocatable head that provides up to ± 15 mm deflection.

Viso Double Glazed – Fully Glazed Partitioning

Our fully glazed partitioning is a double glazed system, Using 88mm wide Head, wall and floor sections with an Internal aluminium post.

It also uses a low carbon Clear plastic Internal post in lieu Of our aluminium internal post.

Viso Double Glazed can also be specified and installed using a two part relocatable head that provides up to ± 15 mm deflection.

Viso Fire & Acoustic – Full or Part Glazed Partitioning

Our full or Part glazed partitioning is a single or double Glazed system,

Using 88mm wide Head, wall and floor sections with Intermediate aluminium posts.

It also uses a low carbon UPVC glazing beads or aluminium glazing beads in single and double.
